


TRUST DEED

- vii) to act according to the decision of the majority of trustees when the trustees are not unanimous and such decision that be binding on the minority as well as on those trustees who may not have votes. If the trustees shall be equally divided in opinion the matter shall be decided according to the casting vote of the Chairman.
- viii) to reimburse themselves or pay and discharge out of the funds or any property and income thereof, expenses that may be incurred in or about the execution of the trusts or powers of these presents, including reasonable amount of travelling expenditure incurred for attending any meeting of the trustees.

Provided that trustees may refuse to accept any such donation/agrant or legacy, which they may in their absolute discretion, consider unsuitable.

The trustees may nicet together for the despatch of the business and adjourn and otherwise regulate their meetings and proceedings as they may think fit.
